





# Miller Rural Justice Fellowship

## Expanding legal aid for rural Mainers

The hills, forests and fields of Aroostook and Washington counties make up one-third of the entire state of Maine. But despite their vast reaches, these rural counties collectively have fewer than 100 working attorneys – that's less than 3 percent of all working attorneys in Maine.

While these easternmost and northernmost stretches of Maine may have low population densities, their need for legal assistance remains high. A 2022 national survey conducted by the Legal Services Corporation found that 77 percent of low-income rural households experienced at least one civil legal problem in the previous year.

Despite the great need for legal aid in Maine's rural regions, recruiting and retaining attorneys in these remote areas has proven challenging. To help address this need, we launched the Elinor and Charles Miller Rural Justice Fellowship in 2024. The fellowship, based out of our Machias and Presque Isle offices, offers recent law school graduates the opportunity to make a difference in rural communities while also gaining valuable early-career legal experience.


The fellowship does not stipulate how many or what types of cases fellows must take on, so they are free to explore all of Pine Tree's focus areas.

Our inaugural Fellow, Jordan Miller (who has no relation to the namesakes of the fellowship), began working out of our Machias Office in September 2024. A graduate of Colby College, Jordan left Maine to go to law school at New York University but returned to intern with Pine Tree at our Augusta Office during his first summer at NYU. After graduating from law school, he decided to return back to Maine and Pine Tree through the Miller Fellowship. “It was a chance to experience something unique while still doing the work that I want to do,” says Jordan, who primarily worked with tenants facing eviction as an intern and continues to take on housing cases as a fellow.

Jordan has also expanded his expertise in other areas of law during his fellowship. In one case, a client needed help navigating a legal dispute with a utility company that demanded that the client pay debts owed by previous occupants of a rental that they were trying to move into. Unless this client paid those debts owed by the former tenants, they could not turn on the electricity in their new home. Jordan represented this client, holding the utility company accountable and gaining valuable new insights and knowledge that he has been able to share with other colleagues at Pine Tree.

In September 2025, we welcomed our second Miller Fellow, J-T Mullins, at our Presque Isle Office. “I wanted to go where I thought there was the biggest need, and that is in Aroostook County and northern Maine in general,” J-T says.

The Miller Fellowship will continue rotating between Machias and Presque Isle each year, with each fellow serving two years. We are proud of what our fellows have achieved so far, and look forward to the future of this program and the justice it will help bring to Maine's rural residents.



## A Legacy of Justice

The Miller Fellowship celebrates the legacy of Ellie and Charlie Miller, who both had careers dedicated to equal access to justice in Maine. Ellie worked on staff at Pine Tree for several decades and currently serves on our Board of Directors. Charlie, who passed away in August 2023, was a pillar in Maine’s legal community. He worked for decades in real estate and business law and offered his expertise and wisdom to Pine Tree and many other charitable organizations.

We are proud to carry on the legacy of Ellie and Charlie through the Miller Fellowship.



# Celebrating 20 Years of KIDSLegal

In 2024, we celebrated 20 years of KIDSLegal, a specialty unit within Pine Tree that exclusively focuses on addressing the unique needs of low-income children and youth in Maine. From investigating unlawful expulsions from school to confronting bullying, we work to ensure that all Mainers have access to justice, no matter their age.

KIDSLegal is Maine's first and only children's rights project.

## What KIDSLegal believes

We believe that an injustice against a child can last a lifetime. That's why we are committed to addressing the most pressing needs of vulnerable youth in Maine to ensure their safety, wellbeing, and access to a meaningful education.

## What KIDSLegal does

We provide direct representation to children, youth, and parents or caregivers on their behalf, and also provide consultations and trainings in Maine about the rights of children and youth.



In 2024, we closed nearly 150 KIDSLegal cases, including this success story:

A young student, let's call him Jack, was in first grade when he was diagnosed with PTSD, anxiety and other conditions that made it difficult for him to focus at school. He was often distressed in class. His school called his mother regularly with complaints and concerns. He sometimes spent the entire day in the principal's office. Eventually, the school took steps to expel him.

Dismayed by this development, Jack's mother reached out to Pine Tree for help. KIDSLegal attorney Katherine Tarpley confidently assured her that she would work to bring Jack the justice and support that he lawfully deserved.

As she investigated the case, Katherine found that the school's planned expulsion violated state law. Instead, she ensured Jack received access to education immediately and facilitated an evaluation that found that he was eligible for services he had not been receiving at school. She helped his mother transfer him to a new school that was able to provide the care and attention that he needed.

Jack had great success at his new placement. Over time, he was able to maintain regulation throughout the day, connected well with classmates and teachers, and excelled in science and math. He and his mother were relieved to have found the level of support that Jack should have been receiving all along, and a solution that allowed him to continue growing into a bright and thoughtful young child. Katherine remained in touch with the family through the duration of the school year and ensured that they continued on a path of success.




